Terms and Conditions

Unless otherwise expressly provided by AIB International, Inc., the terms and conditions set forth herein shall apply to any purchase of products and services from AIB International. By placing an order for any products and/or services from AIB International, you ("Client") agree to be bound by and accept these terms and conditions. If you do not agree to these terms and conditions, you should not obtain products or services from AIB International. These terms and conditions are subject to change by AIB International without prior written notice at any time, in AIB International's sole discretion, and you should review these terms and conditions prior to purchasing any product and services that are available from AIB International.

1. Compensation and Term

AIB International may at various times perform services at AIB International facilities or at Client facilities as directed by Client and agreed to by AIB International. Reasonable and necessary business and travel expenses incurred by AIB International shall be reimbursed by Client upon submission of expense reports with back-up documentation. AIB International shall provide detailed invoices and shall maintain, and provide, upon request, backup documentation for a period of one year from the date of the respective invoices. Client shall make full payment for services within thirty days of invoice. If AIB International brings a legal action to collect any sums due from Client, AIB International shall be entitled to collect, in addition to all damages, its costs of collection, including reasonable attorney's fees.

2. Warranties by AIB International

AIB International represents and warrants to Client that it has the experience and ability to perform the any services AIB International agrees to provide to Client; and that it will perform said services in a professional, competent and timely manner.

3. Warranties by Client

Client represents and warrants to AIB International that it has the power to enter into and perform under these terms and conditions, that it has the power to order products and services from AIB International, and that any and all information provided to AIB International is accurate and that Client has all rights necessary to provide said information to AIB International.

4. Independent Contractor

AIB International acknowledges that the services rendered to Client shall be solely as an independent contractor. Neither party may enter into any contract or commitment on behalf of the other. AIB International further acknowledges that it is not considered an affiliate or subsidiary of Client and is not entitled to any Client employment rights or benefits. It is expressly understood that any undertaking between AIB International and Client is not a partnership or joint venture.

5. Nondisclosure Agreement

If required by AIB International, a Nondisclosure Agreement will be executed as a separate document.

6. Payment

Services may require prepayment based on current AIB International policy. Client agrees to pay any applicable taxes. Invoice will be paid by Client net 30 days after invoice receipt. Payment to be made in U.S. dollars as specified. AIB International will not be responsible for any bank transfer fees, exchange fees, or wire transfer fees to receive payment as due.

7. Cancellation

In the event of cancellation by AIB International or Client, mutually agreeable alternative dates can be selected, if applicable. In the event of client cancellation, liability is limited to preparation time expended and any change fee for travel. In the event of cancellation by AIB International, liability shall be limited to any change fee for travel.

8. Liability and Indemnification

Many services provided to Client by AIB International are based upon information and documentation supplied by the Client. Client is solely responsible for the accuracy of any and all data provided to AIB International to fulfill contracted services, and Client warrants and represents to AIB International that all such data will be accurate. AIB International is not responsible for any errors, inaccuracies, or defects in the data provided to AIB International, regardless of whether Client was aware of any such errors, inaccuracies or defects.

AIB International shall not have any liability to Client or others (whether in contract, warranty, tort (including, but not limited to, negligence) product liability or other theory) for any indirect, incidental, special, punitive, or consequential damages or any loss of revenue, data or profits that may arise from or are related to AIB International's products and/or services provided to Client, even if AIB International was advised of the possibility of such damages. Client, at its own cost and expense, shall indemnify, defend and hold harmless AIB International, its directors, officers, employees, agents, successors and assigns against any claim, suit, action, judgment, liability, loss, cost, expense and other damages (even if such claims are groundless, fraudulent, or false), including reasonable attorneys' fees, based upon or in any way related to any products and/or services provided to Client by AIB International that is/are not due solely to the intentional misconduct of AIB International. For any labeling services provided to Client by AIB International, Client acknowledges and agrees that Client is solely responsible for ensuring regulatory compliance of all labeling, and that AIB International's services do not include compliance guarantees. Notwithstanding anything herein to the contrary, AIB International's aggregate liability arising under or with respect to any products and/or services provided to Client by AIB International will in no event exceed the total amount paid to AIB International for the products and/or services rendered to Client. AIB International shall not be liable for any errors based upon information provided by the Client, the Client's enactment of AIB International's services, or the Client's reliance on AIB International's services.

9. Governing Law; Forum; Jurisdiction

This Agreement shall be deemed to have been executed in Manhattan, Riley County, Kansas, and shall be governed by and construed, interpreted and enforced in accordance with the substantive laws of the State of Kansas, irrespective of any choice of law provisions. All suits, proceedings and other actions relating to or arising out of this Agreement shall be submitted to the jurisdiction of the District Court of Riley County, Kansas, and venue for any such suits, proceedings and other actions shall lie exclusively in Riley County, Kansas. The parties hereto consent to personal jurisdiction and venue in the District Court of Riley County, Kansas, and expressly waive the right to bring any action in, or to transfer or remove any action to, any other state or federal court.

10. Entire Agreement

These terms and conditions constitute the entire agreement and understanding between AIB International and Client concerning the subject matter hereof and supersedes all prior agreements and understandings of the parties with respect thereto. These terms and conditions may not be altered, supplemented, or amended by the use of any other document(s). Any attempt to alter, supplement or amend this document or to enter an order for products or services which are subject to additional or altered terms and conditions shall be null and void, unless otherwise agreed to in a written agreement signed by Client and AIB International. To the extent that anything in or associated with the products or services provided to Client by AIB International is in conflict or inconsistent with these terms and conditions, these terms and conditions shall take precedence.
